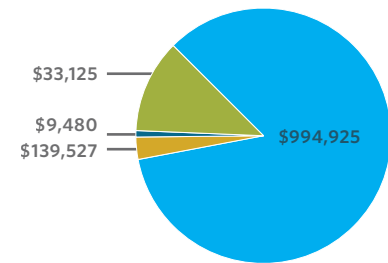


WHO WE ARE

- We are a national network of conservation, scientific, education, religious, sporting, outdoor recreation, business, and community organizations—and more than 200,000 individual activists and supporters.

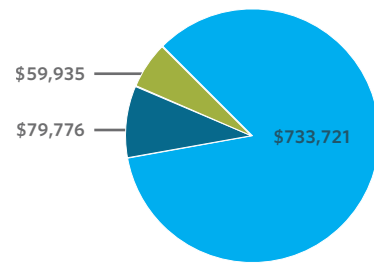

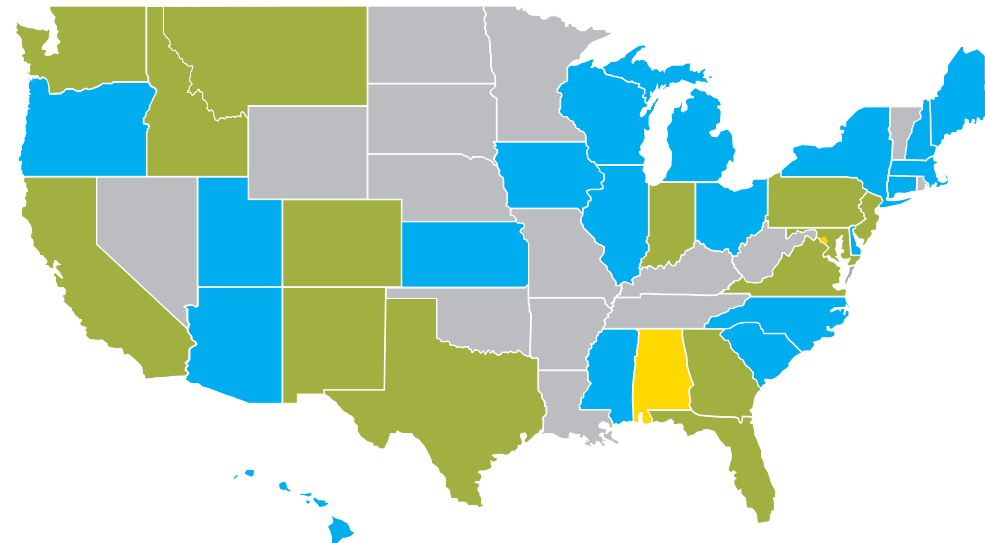


COUNTERING ENDANGERED SPECIES ACT ROLLBACKS

- Secured more than 370,000 signatures opposing Endangered Species Act rollbacks
- Secured 249,000 signatures opposing wolf desilting
- Mobilized 200 activists to attend 77 meetings with 53 Senate offices in 32 states
- Published 65 ESA OpEds and LTEs in 25 states

A 2030 VISION FOR WILDLIFE

- Introduced Wildlife Corridors Conservation Act
- Introduced Pennsylvania Wildlife Corridor Bill
- Restored 23 pollinator habitats in 19 states
- Restored 2 pollinator corridors and migratory flyways
